1. Background

This order shall act as the official order for schools, universities, agencies, and departments within this Court's jurisdiction to change and amend the name on all licenses, databases, certificates, and other official documents under the agencies' control and issuance, whether electronic or paper. This includes, but is not limited to, the Texas Department of Public Safety, the Texas Department of State Health Services (TDSHS), including the Vital Statistics Section of TDSHS, the Texas Secretary of State, and county election and voter registration officials.

The Court **orders** that upon application to the Texas Department of State Health Services, Vital Statistics Section, Petitioner's Texas birth certificate shall be amended pursuant to Texas Health and Safety Code 192.010 to reflect this name change.

The Court finds that the Petitioner was born in the state/country of _____.

The Court authorizes the appropriate officials in charge of correcting birth records and other official records containing identifying information in the state/country of _____ to correct the birth record and other official records with identifying information in accordance with the findings in this order to the extent lawful under that state/country's laws.

The Court further **orders** that the Petitioner not use this name change to avoid past or future financial or credit obligations or liabilities, for the purposes of fraud; or to circumvent any laws or ordinances.

13. Other Orders

The Court has the right to make other orders, if needed, to clarify or enforce this order.

Documents within the file shall not be released except upon court order or upon request of the attorneys of record or the party to the case. The Clerk shall maintain this file as a restricted file.
